



Official Rules for the \$25,000 Ballin' Promotion (the "Promotion")

The Promotion will take place at Turning Stone Resort Casino located at 5218 Patrick Rd., Verona, NY 13478 (the "Promotion Site") on Friday, August 21, 2026 from 7:00am to 9:00pm (while supplies last) (the "Promotion Times"). By participating, you agree to these Official Rules.

Eligibility. Participants must be TS Rewards Members and use their TS Rewards Card to activate and participate in the Promotion. TS Rewards Cards are complimentary. Individuals with proper identification and who are at least 18 years of age or older may obtain a TS Rewards Card. Void where prohibited or restricted by applicable law. Team members, officers and executives of Turning Stone, including YBR Casino & Sports Book, Point Place Casino Hotel and The Lake House at Sylvan Beach, and its parent organizations, affiliates and sponsors, and their immediate family members (mother, father, sister, brother, husband/wife, son/daughter), are not eligible to enter the Promotion.

How to Enter. The first two hundred (200) eligible participants may swipe their TS Rewards Card in the promotional area located in the Emerald Lobby upon earning 125 points at the Promotion Site during the Promotion Times while using their TS Rewards Card. Use of TS Rewards Card during play is required to earn points and to swipe at the promotional area. After the participant earns the required points and swipes their TS Rewards Card, the participant will receive a ball out of the \$25,000 Ballin' prize machine. Each ball will denote the prize awarded.

Prize(s). There are 200 Free Play prizes in the Promotion. The possible prizes are: \$1,000 Free Play, \$500 Free Play, \$250 Free Play, \$200 Free Play, \$150 Free Play, \$100 Free Play, \$50 Free Play, \$25 Free Play and \$10 Free Play.

Winning a Prize; Odds. Participation is limited to the first 200 eligible guests. The odds for the prizes are: \$1,000 Free Play (1:40), \$500 Free Play (7:200), \$250 Free Play (1:10), \$200 Free Play (1:10), \$150 Free Play (1:10), \$100 Free Play (3:40), \$50 Free Play (3:20), \$25 Free Play (9:40) and \$10 Free Play (19:100). After a prize has been awarded, the ball and its corresponding prize will be removed from the prize pool, and the total number of available prizes and odds will be recalculated accordingly. This process continues until all prizes have been claimed or the Promotion period ends. The first 200 participants who qualify for the Promotion during the Promotion Times at the Promotion Site while using their TS Rewards Card will receive a prize. Eligible participants who receive a prize must use such prizes in accordance with any terms and conditions regarding such prizes. In the case of unavailability of any prize, Turning Stone reserves the right to substitute a prize of equal or greater value. All applicable taxes and unspecified charges or expenses are the sole responsibility of the prize winner(s). Claiming Prize(s). All applicable prizes won will be automatically added to the participant's account. Any Free Play prize won must be used within 48 hours of deposit. Failure to use any Free Play prize within this 48-hour timeframe will result in forfeiture of the prize. No compensation will be given for forfeited prizes. Turning Stone and its parent organizations and affiliates shall not be liable for any injury or other harm related to or resulting from participating in the Promotion, claiming or using any prize(s).
